Compounding is the pharmacy method of preparing customized medications tailored to an individual's needs when a commercial medication is not available in the dosage form and strength needed. Many patients are allergic to preservatives or dyes, or are sensitive to standard drug strengths. With a physician's consent, a compounding pharmacist can change the strength of a medication, alter its form to make it easier for the patient to ingest, and add flavor to it to make it more palatable. A compounding pharmacy also can prepare the medication employing several unique delivery systems, such as a troche or lozenge, a lollipop, or a transdermal gel.

Preparing these customized medications allows compounding pharmacists to achieve their ultimate goal: to help the prescriber and patient achieve a more positive therapeutic outcome.

Doug's Compounding Pharmacy is a compounding-only pharmacy providing medications in areas including pain, bio-identical hormone replacement therapy, wound care, hospice, and veterinary medications. Food Stands for July 4th

Any non-for-profit organization that would like to have a food stand at the Chamber-sponsored Old Fashioned 4th of July Celebration, are asked to contact the Chamber office at 379-4655 or contact the sub committee chairman Candi Riecks. The Chamber will assess a small fee to those groups wanting to have a food stand. All non-for-profit organizations will also need to obtain a Temporary Food Permit from the Ford-Iroquois Public Health Department, and a list of guidelines from the Chamber.

The Chamber office has contacted the Ford-Iroquois Public Health Department and a Temporary Food Permit can be obtained at no charge to non-for-profit organizations. A food permit application can be obtained at the website www.fiphd.org and organizations will have to speak with the Health Department at 815-432-2483. The Ford-Iroquois Public Health Department will need all applications into their office no later than June 22, 2013.

On July 4th, the Temporary Food Permit that was obtained from the Ford-Iroquois Public Health Department will need to be displayed at the food stand, and the Chamber will need a copy of the permit before groups will be allowed to have a food stand at the Chamber-sponsored event.


